# 102<sup>th</sup> Annual Convention

# ALLEGANY GARRETT COUNTIES VOLUNTEER FIRE & RESCUE ASSOCIATION Hosted by Cresaptown Vol. Fire Dept. SATURDAY, JUNE 7, 2014

President Gene Kidwell called the 102<sup>th</sup> Annual Convention of the Allegany-Garrett Counties Volunteer Fire & Rescue Association to order. The Convention convened at 10:30 a.m. at the Cresaptown Vol. Fire Dept., for the purpose of transacting any business that may come before the association.

Past President and Chaplain Calvin W. "Pete" Walbert noted there were 28 fire and rescue personnel and 9 auxiliary members memorialized at this morning's joint memorial service, Chaplain Walbert read the 23<sup>rd</sup> Psalm in his memory.

President Kidwell then called upon Chaplain Walbert to open the morning session with the invocation, which was followed by the pledge to the flag led by Vice President CB Broadwater.
